AGENDA ITEM:

Appointments for vacant positions on the McMinnville Urban Renewal Agency Budget Committee

BACKGROUND:

ORS 294.414(1) requires a local government to establish a budget committee for purposes of acting as the local government's fiscal planning advisory committee. The committee is comprised of the elected members of the governing body and an equal number of electors of the local government (i.e., qualified voters). The governing body appoints electors to the budget committee for three years terms.

Resolution No. 2014-2, adopted by the McMinnville Urban Renewal Agency (URA) Board on March 11, 2014, established the URA Budget Committee and provided that the City of McMinnville Budget Committee shall also be appointed as members of the McMinnville URA Budget Committee.

There are currently four vacancies on the City and Urban Renewal Agency (URA) Budget Committees. The vacancies were advertised in the News Register on September 30, 2016 and October 7, 2016, as well as on the City website. There were no responses to the advertisement at that time. In recent months, applications for the Budget Committee were submitted by Peter Hofstetter, Drew Millegan, and Kyle Lake.

Candidates Hofstetter, Millegan, and Lake are scheduled to interview with Mayor Hill and Council President Menke at 4:00 p.m. on April 11th. Interviews for the URA Budget Committee will be held in conjunction with interviews for the City of McMinnville's Budget Committee.

RECOMMENDATION:

Staff recommends that the URA Board appoint the candidates to the Budget Committee, as recommended by Mayor Hill and Council President Menke.
