For the Period of June 29 to July 5, 2020

Old Sheridan Road Project

Project Dates: June 15 - October 15, 2020

- SW Old Sheridan Rd between SW Goucher St and SW East St will be closed
- SW Old Sheridan Rd between SW Cypress Ln and SW Goucher St lanes closures will be intermittent

Vehicle detour will be marked on SW Cypress St to SW Fellows St to Highway 99W. Pedestrian detour will be marked on SW Goucher St to SW Fellows St to Highway 99W.

Work will include widening the road, storm water management improvements, retaining walls and bridge replacement. Please be cautious and obey traffic control devices, flaggers, road closures and detours when they are in place.
