Mr. Mayor and Councilors.

During the early 80's I sat in your seat and was councilman of Ways and Means. We were warned that we would need to come up with ways to help the general fund, because we could see a future shortfall coming. We decided to start getting each department to be as lean as they could be without effecting city services.

I understand you are planning to assess a franchise fee on every household and business that uses the Water and Light services. My understanding is a franchise fee was put in place for vendors to be exclusive providers to the city, and they paid a percentage, as a fee to be a vendor. Then they were allowed to charge the users for the cost of doing business in McMinnville.

The proposal before you is a TAX. You can not get around it. You are proposing to tax the users of the system for the privilege of being a Water and Light customer.

McMinnville Water and Light was never meant to be a cash cow for the city. The separation was done for a reason. While I am not a lawyer, I was around many of the old members of the W&L Board and the only reason for the sewer bill being included is because the W&L was already set up for billing. Now you're going to tax us for the use of the system you already own. It's not like we have a choice in providers.

The fairgrounds has 39 fixtures on the property that use water. The water bill is \$358.00 per month, which make's each fixture cost at \$9.18 to operate and provide water to the public. The sewer bill is on average \$1798.00 per month, which is \$46.11 for water to go down a pipe. Now if you look at the usage, 80% of the water actually goes on the ground and not back into the system. This is because the water is used for dust control and water for the animals who visit the facility. Now you want to add another 7%, or \$125.86 to the sewer bill which is \$3.23 per fixture. This will now make it almost \$50.00 per fixture to use for sewer. This is not counting the water tax and electrical so you can see indoors to use the fixtures at night. This is the effect at the fairgrounds. On the personal side, you say its only \$20.00 per household added to my current \$200.00 Utility bill. Now one of you will come out and say, well what would it be if you lived in Portland. Yes, my bill will be a lot higher, but I do not live in Portland and if you are happy to pay for all the services they charge, for which, in some cases, is another house payment, then by all means move to Portland. I was born here and chose to live here and not in Portland.

You are requiring me to upgrade my sewer pipe to hook into your system at a cost of \$3000.00 and are now charging me \$50.00 per month, till my contractor can get to fix it. Now you want to add another 7% to my home sewer bill. I feel like the city is holding a gun to my head. What's next a tree tax, grass tax, possible air breathing tax? I am sorry, you mean a franchise fee! Why don't you have your staff look at their departments and get their opinion how to make the department clean and lean. If they cannot do it, then get someone who can. Business has been doing it or going out of business. It is sad how

many of the great business have had to close or will leave because they could not make it in McMinnville.

You have a responsibility to the citizens to keep services affordable. \$20.00 to some of our citizens is the cost of a prescription, a meal or paying their utility bill. We were always aware of our fixed income residents. Staff is going to have to reach deep to make each department lean and not take out their frustrations on the citizens of McMinnville.

I would like to request that you vote against this franchise fee. While a yes vote may ease your pain in the budget process, it will have long lasting and far-reaching effects in future. Please vote no for these new taxes.

RE: Public Hearing on Funding Sources

Dear Mayor Hill and Members of the Council:

Thank you for allowing the citizens to comment on potential funding sources to maintain city services and balance the budget.

<u>City Services Fee:</u> While it does not appear that the Council is considering a city services fee on utilities at this time, it continues to be discussed as a desirable option. I believe this is a bad policy choice that will primarily impact those least able to pay and encourage wasting limited resources.

A city services fee will increase the fixed portion of the utility bill, commonly referred to as the service charge. This is the amount charged to every customer, regardless of how much they use of a utility service.

The current monthly service charges for typical households for the three utility services provided by the City are as follows: Water \$14.30, Electric \$15.10 and Sewer \$22.38. In other words, before you turn on the tap, flip on a light switch and or flush the toilet, you are billed \$51.78. A city services fee would increase this fixed portion of the bill, leaving many citizens paying more for the service charge than the actual service provided.

For example, looking at the Water and Light bill for our home during the winter we use an average of 300 cubic feet per month of water. We pay \$4.87 for the water (charged at \$1.6247 per 100 cubic feet) and \$14.30 for the service charge for total of \$19.17. Similarly, we pay \$18.21 for sewer to dispose of that water (at \$6.07 per 100 cubic feet) and \$22.38 for the service charge for a total of \$40.59. Less than 40% of the billing we receive for these services actually goes to the cost of the service and more than 60% to the overhead making up the service charge calculation. Any sort of city service fee based on a meter would exacerbate this imbalance.

Over the years during utility rate hearings in front of the City Council and Water and Light Commission I have objected to the continuing increase of the service charge as a proportion of the bill. I have reviewed the calculations used to determine the service charge and believe they have a factual basis. However, the consultants preparing those allocations of cost both acknowledge that the assumptions of which costs should be included in the service charge are not always clear, so judgment is required.

Beyond the impact of imposing excessive service charges to customers needing small amounts of utility services, I believe such charges reduce the incentive to conserve resources. When most of your bill is tied to consumption of the utility resource, citizens get a proportionate reduction in their bill when they reduce consumption. In the example above if we reduced our consumption by one-third to 200 cubic feet per month the water bill would go down by \$1.62. Were our bill based entirely on consumption of water it would reduce by more than \$6.

Given that we will eventually need to be investing millions to supplement our pristine Nestucca River water source with Willamette River water and that we face higher Tier Two BPA electrical rates if consumption of power increases significantly, I think we should be doing all we can to give clear pricing signals to consumers that they should be saving water and power. (The impact of conservation on the sewer treatment plant is a more complex topic, but generally reducing the flow through the plant is a good thing.) A city utility services fee as presently described would have the opposite effect, reducing the incentive to conserve.

Water and Light has already made clear that it will be very complex and expensive to accommodate a city services fee on the utility billing system. The irony of this is that the next time the consultants do a rate review, they would add this overhead billing cost into the customer service charge calculation, meaning that the customers would pay an increased service charge so that they could be charged the added city services charge.

Adding a city services charge on utilities is a regressive tax on those least able to afford it and does nothing to encourage conservation of limited resources. Please reject the idea.

<u>Payment in Lieu of Taxes (PILOT)</u>: As a funding source, this is fairer than the city services fee because it is based on the total revenues received, which include actual use of the utility service. It is also costs less to implement. Most citizens will pay less using this model.

Regardless of what percentage level you choose to impose, I firmly believe it should be the same for all users. Giving a 50 percent reduction to the two users who use the most electric power is illogical and unfair. Why not give a 50 percent reduction to small businesses that are struggling to survive or to senior citizens on fixed incomes?

And I don't believe we need to "phase in" the decision to charge everyone the same rate. The ratepayers in this community have subsidized Cascade Steel and Airgas for decades to the tune of millions of dollars. I don't recall ever hearing even a "thank you" for our contributions to their bottom line.

The Need for a Revenue Increase: As part of a series of work sessions with the Council and Budget Committee, city staff produced a detailed spreadsheet listing the 145 city core services with descriptions of those services provided in 4 categories: Below Base Level, Base Level, Mid Level, and Optimal Level, identifying in which category each of the services currently falls. This is an excellent resource for having a public discussion about what and how much we want city government to do.

Unfortunately, no public discussion ensued about whether we need to increase current service levels, and the Council moved on to analyzing the best ways to increase revenues. We're now left in the awkward situation of asking for fee increases when the public has not been convinced of the need.

Who Pays the Taxes/Fees To Maintain/Increase City Service Levels?: Of course, the best tax is the one someone else pays. There are various ways to raise money for government services including taxes/fees based on income, property and services provided. The fees under Council consideration have the disadvantage of falling proportionately more heavily on those who can least afford to pay them.

The 2019 draft Housing Needs Analysis shows that 36% of McMinnville residents are considered cost-burdened, meaning they are paying more than 30% of their income for housing and utility costs. Given how housing costs have increased over the past several years, this cost-burdened percentage has likely increased.

If you were to apply "levels" to resident incomes like the city did to core services, I would argue that the cost-burdened residents are "Below Base Level." Looking to them to increase revenues seems unfair, especially since raising utility costs increases their housing cost burden.

Conclusion: While I am supportive of maintaining city services and increasing them in some areas, I don't believe the city has made an effective case for increases at this time. I would favor charging everyone the same 6% PILOT on electrical services. If additional funding is necessary to maintain existing service levels, I would favor a small, temporary PILOT on water and/or sewer service that would sunset after 12 months

During the next year the city would have an opportunity to make the case for the fire district, the approval of which would free up existing funding for other general fund needs. I would also urge the city to hold monthly town halls dedicated to covering one area of core services to explain to the public the cost and benefit of various service levels, both to better inform the public and to build constituencies that would understand and support increasing revenues to support those services.

Dear Council:

I am the general manager at McMinnville Water Light. I write again at the direction of the Water and Light Commission with additional concerns about a proposal to create an electric franchise fee on earnings of the McMinnville electric department's electric fund.

As I wrote in my letter to you dated April 11th, the Water and Light Commission has the authority of the City of McMinnville under the city charter to operate and manage the city's water and light departments (charter section 51). Funds paid to the water and light departments are under the jurisdiction of the commission (s. 46). The charter requires that water and electric funds are kept separate and apart from the other funds of the city (s. 59). The commission determines the manner of withdrawal of these funds (s. 49). The City of McMinnville's authority to transfer money out of the water or electric fund rests with the Water and Light Commission. Under the charter the city council does not have authority to withdraw or transfer money from the water and light funds.

Electric (Franchise Fee):

The Water and Light Commission owns and operates the light plant and electric system on behalf of the City of McMinnville. The charter provides authority to the commission "to construct such pole lines, transmission lines and other devices within or without the corporate limits "(s. 51). Under the charter the commission has the authority of the city to "construct, erect, [and] maintain" an electric system to furnish the city and its inhabitants with electricity (s. 51). Where the electric system lies on city property or right of way, the commission has jurisdiction under the charter to construct and maintain the city's electric system. The citizens of McMinnville, who approved the city charter, granted to the commission authority to operate the electric system in the city right of way. The commission needs no additional authority from the city council to use the city right of way.

In addition, state law specifically excepts municipal electric utilities from payment of a privilege tax for use of the city streets, alleys or highways. See ORS 221.655(1). This exception is consistent with the "PILOT" statute restriction (ORS 225.250) limiting the use of earnings of a municipal electric system to the electric system itself. As I pointed out in my letter dated April 11th, state law only permits a transfer of electric earnings out of a municipal electric fund into a municipal general fund under the authority of ORS 225.270

(with a finding as to adequate surplus funds by the commission as "officer" in control of the electric system). There is no authority for a privilege tax.

The proposed transfer of funds from the electric fund to the general fund in order to pay for general fund expenditures is also inconsistent with the charter's requirement to keep electric funds separate and apart from other city funds. The council lacks authority to order such a transfer, and the commission lacks authority to transfer electric funds into the general fund, except as authorized in state law under ORS 225.270 (as observed and enforced by the commission as officer in charge of the electric system).

The commission recognizes the electric department's duty and authority to pay actual costs caused by the electric system to other city funds. The electric fund commonly pays costs in the form of fees and charges that it causes to other city departments. However, the commission (on behalf of the city) owns and operates the electric system in the right-of-way. There is no basis to require compensation in the form of a privilege tax from the electric department fund for the mere occupation of the city right of way.

Thank you for taking the time to read this letter and consider the commission's concerns. The commission staff remains committed to continuing conversations with city staff to address topics raised in this letter.

Dear Mayor Hill, Council President Drabkin, and Councilors.

McMinnville Economic Development Partnership (MEDP) respectfully submits comment on the proposed increases to PILOT (payment in lieu of tax), and wastewater, water, and electric franchise fees that will impact electric and water users within the City of McMinnville. Please consider the following:

1. Increasing all PILOT fees to 6% will not be equitable. "The U.S. Energy Information Administration (EIA) shares independent and impartial energy information to promote sound policymaking, efficient markets, and public understanding of energy and its interaction with the economy and the environment. Electricity prices vary by type of customer. Retail electricity prices are usually highest for residential and commercial consumers because it costs more to distribute electricity to them. Industrial consumers use more electricity and can receive it at higher voltages, so supplying electricity to these customers is more efficient and less expensive. The retail price of electricity to industrial customers is generally close to the wholesale price of electricity." 1

2. McMinnville's competitive advantage as a leader in affordable utility rates will be impacted.

McMinnville has a competitive advantage as the third-lowest utility rate in Oregon. This is a well-known community benefit promoted by economic developers throughout the state. Low-cost utilities can offset transportation costs for companies considering locations on the I-5 corridor to include McMinnville as an alternative. Furthmore, low-cost utilities have helped the community attract, retain and expand one of the largest traded-sector businesses providing 400 family-wage jobs and 1,200 indirect jobs in the region.

3. Limit the cost recovery ability of McMinnville Water and Light.

Utility prices generally reflect the cost to build, finance, and maintain transmission and distribution of electricity, water and wastewater. The proposed additional fees will be used for the city's general fund and would not be available to McMinnville Water and Light to maintain and expand the utility infrastructure.

MEDP urges the council to postpone a decision on any utility fee increases and consider engaging in collaborative problem solving roundtables with business and community leaders.

RE: City of McMinnville Proposed Utility Fee Increases

Dear Mayor Hill and Councilors:

We have been approached by the McMinnville Chamber of Commerce, Cascade Steel, and residents of the city with great concern over the new, proposed utility fee increases. Normally, we wouldn't weigh in on city-related matters but the concern over the impact of these new fees is growing and we feel it is important to advocate on behalf of ratepayers.

The proposed utility fee increases would have an immediate, negative impact on McMinnville's businesses, namely your largest employer Cascade Steel. Cascade is the only steel mill left in Oregon and they have survived a challenging industry by investing in technology that allows them to be good stewards of the environment while remaining competitive in a commodity market. This isn't an easy task and Cascade Steel, along with its 400+ employees, depend on a healthy partnership with the city and county. This partnership includes a prior agreement that Cascade Steel pays a 3% PILOT as an incentive to staying in McMinnville, providing livingwage jobs, and boosting the local economy. Cascade is an anchor industry and we have seen the value of this company not only in the jobs they create, but the philanthropy they engage in throughout the county.

The proposed increase in PILOT fees from 3% to 6%, a new 6% Electrical Franchise Fee, a new 6% Water Franchise Fee, and a 6% Wastewater Fee would result in a yearly cost increase of \$1.6 Million to Cascade Steel. That's an immediate 300% increase. As with any commodity business, cost increases cannot be passed on to the consumer in the form of price increases. If these proposed fees pass, Cascade Steel will be constrained from growing its business and protecting the jobs that employ our residents.

In this time of economic uncertainty, we cannot express how concerned we are about these significant increases to the utility costs of McMinnville's small businesses and its residents. With inflation at 8.5% and gas and food costs rising daily, additional utility taxes will be unnecessarily punitive.

Just last week, we toured the DCI Newberg building that was lost to a catastrophic fire, immediately displacing almost 90 employees. County, city, state, and industry partners responded by turning over every stone to look for a solution that would protect those jobs. It was a reminder to all of us how critical the role our large employers play in the economic health of our communities.

We urge you to reconsider these proposed tax increases and find other solutions to solving the city's budget shortfall, solutions that don't disproportionately harm the employers that we should be fighting to keep and that protect residents during this tough economic time.

The McMinnville Area Chamber of Commerce represents approximately 450 member businesses in the McMinnville area who are committed to growing business opportunities in our community. We are writing today to express the concerns of your constituent businesses regarding the proposed franchise fees as well as the city service fees.

As we have stated in prior communications, we are concerned about raising taxes and fees without fully examining and discussing options and alternatives. These decisions are too high impact to not have them fully explored by the business community. We are not in support of increased fees until the City of McMinnville brings the economic development partners (McMinnville Economic Development Partnership (MEDP), McMinnville Downtown Association (MDA), Visit McMinnville (VM), and the McMinnville Chamber (MACC)), the business community and citizens to be a part of the conversation to develop an equitable solution that works for all. I have read the updated packet for the Council Meeting on 4.26.22. I read through Resolutions 2022-19 through 22. My name is Christine Bader. I live here in McMinnville with my husband and our nine-year-old twins. We are heavy active users of the Library and Parks & Rec's offerings, and like everyone joining tonight, we are heavy passive beneficiaries of all of the other City services that make McMinnville a wonderful place to live and work.

I chair the City's new Diversity, Equity and Inclusion Advisory Committee, created by this Council last year to help ensure that we are a compassionate and welcoming community for all.

I share that not because I speak for the entire committee tonight, because I do not; but because you appointed me personally to help represent voices in our community that historically have been underrepresented or marginalized.

I am here now to do that: to emphasize that the people who benefit the most from City services, the people who are most hurt by cuts in those services, are the people who you are least likely to hear from in this setting—because they do not have the time or the language or the metaphorical or literal bandwidth to provide testimony to you, even if they knew about this forum and felt comfortable accessing it, which many do not. So while it may sound odd to advocate for an increase in fees, *I* know that services cost money, and I believe that everyone understands that costs go up over time and need to be covered. I also know that this Council and staff are committed to ensuring that the *families* who truly need support paying these fees will receive it.

I appreciate that this is complicated, and that no one likes to raise fees, and that businesses play a critical role in our community and their voices should be heard.

But I urge the Council to bear in mind that prioritizing the voices of business <u>over</u> the voices of people who use and need City services the most would run counter to your duties.

Our City needs additional revenue to support the services that make it a great place to be for everyone, and I support the Council and staff in finding ways to do so.

6 years ago we were looking to put down roots and we made a list of what our ideal location and city would have. When we came to McMinnville for my husband's job interview we ate on third street, took our kids to the dragon park and visited the library. We could tell this is where we wanted to raise our children, this was the community we wanted to be apart of. You know what wasn't on our list for the ideal city- low utility fees.

Looking at the cities around our size they all have some combination of fees to overcome their lack of funds because of the limits set on our property taxes by our state government. Our pattern of using our savings is unsustainable.

I have been talking at preschool pickup, soccer sidelines, battle of the books tournaments and the community members I talk with support funding our city. A lot of them are too busy or intimidated to come here and speak up.

Raising the PILOT to 6% for all, is the bare minimum of what you should approve tonight. McMinnville has so much potential and I am excited about it!

I support additional revenue sources so we don't have to cut city staff or services. Thank you for your time.

Dear Mayor Hill and City Councilors:

Cascade Steel appreciated the Council's grant of its request at the last Council meeting for additional time to consider its proposed actions regarding Resolutions 2022-19, 2022-20, and 2022-21 relating to the proposed PILOT increase and franchise fee increases. As promised, my team and I have been working in the interim on this issue, catching up on the process, and holding meetings with City officials with the desire to find a solution that can work for Cascade, the City, and the entire community.

In two separate meetings with the Mayor and City Manager, I presented a plan by which Cascade would agree to increase the PILOT rate it pays from 3% to 6% using a phased-in approach. The first increase to 4% would occur on September 1, 2022. The second increase would occur on March 1, 2024. In addition, the City would have to agree to not increase the PILOT rate in the ten years following March 1, 2024. This solution assumed that there would be no increase in other franchise fees. In exchange, Cascade would drop its public opposition to the PILOT rate increase, and Cascade's prior opposition to other franchise fees would no longer be relevant.

Unfortunately, at that same meeting we learned at that the City planned to propose yet another new franchise fee on electric users at a rate of 6% in addition to the other two fees still on the table: a new water franchise fee of 6% and an increase of 1% in the wastewater franchise fee. Cascade went into the Mayor's office willing to give a 3% increase on the PILOT at an additional estimated annual cost of \$500,000, doubling the amount of tax paid, but instead left with the news that we, and the residents of McMinnville, might be seeing 13% increases to utility fees and Cascade's PILOT rate would still increase by at least 3%.

If the PILOT fee is increased to 6% and the electric franchise fee is enacted at 6% that would result in an increase of approximately \$1.6M per year. At that rate, Cascade would be solely responsible for approximately 45% of the estimated \$3.4M of incremental annual revenue generated from this proposal.

It is true that Cascade is the largest electricity user in McMinnville. It is also true that Cascade began paying a lower PILOT rate in 1988-1990, which was created as part of the City's support for Cascade's construction of its new Melt Shop. The Melt Shop is state-of-the art and highly energy intensive when it charges to "melt" the feedstock, which consists of recycled metal, to feed our Electric Arc Furnace (EAF). Due to Cascade's hard work and efficient choices, Cascade's EAF is one of the most energy efficient in the business. But the fact is that there is an energy-intensive element to recycling metal into new products, which is what we do.

We understand the City's stated goal is to increase revenues by approximately \$1 million to \$3 million annually. However, as I testified previously, no business can absorb this drastic and immediate increase in costs, but it is particularly detrimental to a business like ours, which is a cost-sensitive commodity business that competes in a global market. As McMinnville's largest employer with approximately 400 employees, including 280 members of United Steelworks Union, our operations indirectly support approximately 1,600 jobs in the city. We are concerned that the economic impact of a drastic combined tax increase, will be felt beyond just our operation

We continue to want to work hand in hand with the Mayor, the City Manager, and the City Council to find common ground that both helps close McMinnville's budget deficit and sustains Mill operations. We stand by our prior compromise solution, and encourage the City Council to adopt the following:

- Increase Cascade Steel's PILOT rate from 3% to 6% using a phased-in approach. The first increase to 4% would occur on September 1, 2022. The second increase would occur on March 1, 2024.
- No increase to Cascade Steel's PILOT rate in the ten years following March 1, 2024.
- No increase in other franchise fees.

Although I am unable to attend tonight's meetings due to prior engagements, representatives from Cascade Steel will attend this evening's City Council meeting. We appreciate your consideration of our proposed solution.



Dear Mayor Hill and City Councilors:

Cascade Steel and its parent company Schnitzer Steel, Inc. acknowledge and are grateful for the City Council's willingness to take time for discussions with Cascade Steel about the proposed PILOT increase and franchise fees. However, Cascade Steel is dismayed by the resulting proposals from City staff now before City Council.

As I noted during my testimony to City Council on April 12, 2022, the proposed increase in PILOT payments (and perhaps the existing PILOT payments) is unlawful under ORS 225.250 and ORS 225.270 because the funds will be spent on general municipal purposes and will not be used to reduce property taxes in McMinnville. Nevertheless, after discussions with the City, Cascade Steel is willing to forego a legal challenge and has proposed to pay a phased-in increase in PILOT payment that would raise the rate from 3% to 4% starting on September 1, 2022 and then to 6% on March 1, 2024; provided that the City does not further review or raise the PILOT rate for at least 10 years after March 1, 2024. This proposal would provide significant additional revenue to the City beyond what it currently receives, without any litigation expense for the City or any risk of losing the current 3% PILOT revenue.

In response, Cascade Steel learned that City staff are now proposing what they are characterizing as a 6% water franchise fee, a 6% wastewater franchise fee, and a new 6% electric franchise fee. This is even less sustainable for Cascade Steel than the package being proposed by the City two weeks ago. The new set of proposed fees would raise even more revenue (according to City staff, \$3.4 million rather than \$3.3 million) and an even larger percentage of the burden (according to City staff, 63%, rather than 55%) would be borne by commercial/industrial users like Cascade Steel. Cascade Steel cannot undertake this new financial load without considering all its options, including a judicial challenge to the PILOT and electric franchise fee. Crucially, City staff's new package of revenue proposals is not any more lawful than the last one. It suffers from at least two legal problems.

First, a so-called "electric franchise fee"—just like the PILOT—violates ORS 225.250 and ORS 225.270 because the funds will be spent on general municipal purposes and not to reduce property taxes in McMinnville. It does not matter whether the City calls the charge a "franchise fee" or a "payment in lieu of tax" or a tax or some other creative label. ORS 225.250 still provides that the "[t]he earnings of the electric plan or distributing system" shall not be spent "for other municipal purposes" except as provided in ORS 225.270. The City cannot dodge that clear prohibition merely by calling the charge a "fee." Otherwise, ORS 225.250 would be meaningless, because any city that owned and operated a municipal electric system could extract as much money as it liked for general municipal purposes, merely by imposing a "fee." In light of the clear purpose of ORS 225.250 and ORS 225.270 to prevent municipalities from using their electric systems as piggy banks without correspondingly reducing property taxes, an Oregon court would not read a "fee" loophole into them.

Furthermore, the City and its officials are not excused from complying with ORS 225.250 and ORS 225.270 by any of the justifications that were alluded to at the last City Council meeting. It does not matter if the City has imposed a PILOT for decades or if a 6% PILOT for industrial users was in effect at some point in the past. Whether or not those actions were lawful at the time, imposing a 6% PILOT is not lawful now. Similarly, it does not matter if other municipalities with electric systems also rely on PILOT payments. City action that is unlawful does not become lawful merely because other cities might be breaking the law too.

Second, even aside from ORS 225.250 and ORS 225.270, there is another legal problem with the proposed water and electric "franchise fees." Section 51 of the City Charter precludes the City from extracting any charge from McMinnville Water & Light as a condition for using public rights-of-way for either electric or water services. Section 51 grants the McMinnville Water & Light Commission ("MWL Commission") the "power and authority" to "construct, erect, maintain, rebuild, repair or enlarge, manage, operate and control" the water plant and electric system, and to "construct * * *, keep, conduct, repair, rebuild, enlarge, and maintain" "all necessary plants or facilities of a character and capacity sufficient to furnish * * * such water and electric energy as may be called for." Section 51 further grants the MWL Commission the power to "construct such pole lines, transmission lines, and other devices within * * * [City] limits, as shall be necessary to carry out the powers herein granted." Water and power lines and associated equipment within City rights-of-way are facilities that are necessary to furnish water and electric services to users within the City. Thus, the Charter already grants the MWL Commission the right to construct, keep, and maintain those pipes and lines in City rights-ofway. And the City Council has no power to undo what the voters have done. Because City voters already granted the MWL Commission the unconditional power to construct, keep, and maintain necessary facilities, the City Council cannot now strip the MWL Commission of that power by conditioning it on payment of a "franchise fee" or any other charge for occupying the right-of-way.

Finally, Cascade Steel is disappointed in the City's failure to live up to its mission statement. The City of McMinnville's mission is to deliver high-quality services "in collaboration with partners for a prosperous, safe, and livable community." And the City's values include "Stewardship," meaning that "[w]e are responsible caretakers of our shared public assets and resources." Here, Cascade Steel pointed out a legal problem—one being created by the City, not by Cascade Steel—and asked to work collaboratively with the City. In response, City staff are doubling down to put even more financial burden on Cascade Steel, without even solving the original legal problem. That is not a good-faith collaboration. It is not sustainable caretaking of public assets. And it is not the path to a prosperous community.

Cascade Steel values its partnership with this community and its role as an engine of economic activity. But Cascade Steel cannot be the City's piggy bank. Cascade Steel asks the City not to impose any of the four proposed charges. However, Cascade Steel's proposal of a phased-in PILOT increase as described above (including certainty that the PILOT will not increase again until 2034) remains on the table if the City is willing to work with Cascade Steel in collaboration as a true partner rather than piling charges onto utility users. But if the City rejects Cascade Steel's PILOT proposal or adds an additional franchise fee (or some other new charge) on top of the PILOT, Cascade Steel will be forced to consider judicial action against the City.

My name is Andrew Jones, and I am the president of the McMinnville Swim Club. The Swim Club is a non-profit that has been around since 1976. We have over 100 families in membership, and we have the ability to rapidly grow if we had sufficient pool space. We are a long-time business partner with the City. We are, I believe, the largest tenant of the Aquatic Center. We have a lease pursuant to which we pay a market rental rate for access to the pool 6 days a week. We have been told that our rent will be increased by 8%. While this will be difficult for the club, we understand that the City's costs are increasing and it is fair that we pay our share.

I'm not here to directly address the resolutions at issue, but rather to describe to you the negative impact that the City's budget deficit has had and will have if not rectified.

McMinnville built a gem of an aquatic center, one which was an envy of many swimming people around the state. However, due to years of deferred maintenance, we now have a facility where staff has to place garbage cans out to catch the leaks from the roof, one where we can't hold a swim meet without having a bathroom go out of order.

It's also a facility that the City has not been able to keep open. For much of 2021, the Aquatic Center was closed on Saturdays, and during the 23-week furlough of City employees, it was also closed on Fridays. That meant that for almost half of 2021, we lost 1/3 of our rented pool time.

As you would expect, it's difficult to run a successful swim club with these limited hours. We lost swimmers because of the limited hours, and we would likely lose more with subsequent furloughs and closures. I would think it's also difficult to establish and grow a customer base for the Aquatic Center without reliable and consistent access to the pool.

I urge you to consider the long-term impacts on McMinnville. Without even considering all of the families who go to the Aquatic Center for open swim, the seniors who go to arthritis exercise class, or the many other users of the Aquatic Center, the collective hours of swimming lost by our swimmers was over 8,000 hours in 2021! Given the childhood obesity epidemic, and the lingering mental health effect on children from COVID, we should be finding more opportunities for them to exercise, rather than taking them away.

Also consider the impact on future generations. Most who have lived in McMinnville for very long have had a child, a grandchild, a niece, a nephew, a friend, or perhaps yourself learn to swim at the Aquatic Center. There is a good chance that the instructor was with the Swim Club! Swimming is a life skill, and one that needs to be taught and passed on from generation to generation.

So my request is that you please keep in mind that closing the budget deficit by cutting expenses will result in a lower quality of life for current residents and unforeseen problems for future generations.

What are we talking about?

Each year, our cost of providing services has exceeded the amount of money coming in.

As a result, during the annual budget process, we have used these strategies to make up the difference:

- Used our reserves (the city's savings account)
- Reduced our service levels (through furloughs or hiring freezes)
- Postponed important capital investments (limiting how we plan for our future)
- Deferred maintenance on city assets (waiting to repair or replace things)

Yet, a persistent budget gap of approximately \$2 million exists in the general fund.

Revenues for the General Fund typically increase by 3% each year, and the City's expenses by around 6%. (You don't have to be math savvy to see the problem.)

We're struggling with a sustainability issue folks – this is a problem because the city is required by law to adopt and operate within a balanced budget.

Here's what has happened so far:

- ➤ In 2019 we implemented a wastewater franchise fee.
- ➤ We've explored the feasibility of creating a fire district with intent to improve fire and ambulance service delivery across the larger McMinnville area (this should help free up property tax revenue for other uses within the city).
- ➤ The state gas tax has provided basic funding for street maintenance and stormwater management, but capturing everything that needs to be done within this structure is complicated.

During a poll last year, we learned that the community was supportive of us looking at ways to reinvest in our services.

While this work started around 5 years ago, the conversations about addressing the deficit has been a key goal of the Council for the past 9 months. We've been working closely with our budget committee and City Councilors to look at the available solutions that would protect our declining reserves (remember, that's the city's *savings* account).


The work has emphasized looking at resources that balance the financial burden between residents and businesses, with special consideration for the most vulnerable members of our community.

What is the General Fund?

The City's General Fund supports police, fire, administration, parks and recreation programs, library services, short- and long-range planning, code enforcement,

emergency preparedness and more – basically every service you can think of when you think of the *services* we need to have a healthy community.

Here's a quick snapshot of how its currently funded:



How did we get here and why do we need more money?

The bottom line?

Revenues just can't keep up with community needs.

The budget problem is a result of funding City services with property taxes that only raise by a little while living in a world where expenses raise by a lot. This situation is rooted in property tax ballot measures from the early 1990s in which voters chose to cap property tax revenues. Without other revenue sources (like a sales tax), all 36 counties in Oregon have been faced with the challenge of addressing budget shortfalls.

We have a history of taking a fiscally conservative approach on capital spending. Over the previous decades, the city prioritized funding which focused on *basic services and staffing levels* – which diverted funds away from capital investments. As an example, deferred maintenance on our street vehicles has our fleet age at over 20 years old. Why is that important? We need street maintenance vehicles to keep our streets free of potholes, cracks, and to provide the ongoing maintenance that prevents larger, complicated, and more expensive problems.

The costs of services have increased, and our city services rely on people. Costs to provide health insurance, competitive wages, and the general cost of doing business (materials, supplies, contracted services, etc.) has increased as well as the cost of public sector retirement. McMinnville must strive even harder to compete with the current economic climate.

Community members asked us to envision a future and high quality of life for all McMinnville residents. And as a result, we implemented MacTown 2032. Staff are five years into the fifteen-year strategic plan focused on implementing the work that supports the City's core service areas. To ensure we maintain an excellent level of service we must look beyond our current model to find solutions which minimize the spending of our reserves to balance the annual budget.

A 2019 study of the condition of City facilities revealed that over \$10 million in facility maintenance is needed over the next 5 years. These findings prompted the Council to create a new community advisory committee – the MacPac – which has worked hard over the past 18 months at exploring our options for a new community center, aquatic center and library facilities – invaluable community assets which are near and dear to our hearts.

Other sources of funding have been limited to specific services or projects.

Examples of these "restricted revenues" include:

- Property tax from the 2014 voter-approved transportation bonds for rehabilitating and repaying streets in McMinnville can only be used for those projects.
- Property tax funding for the Urban Renewal District and voter approved bonds in 2001 for Parks Improvements and 2006 for the Public Safety and Civic Center buildings (ending in 2025).

What can I expect if I support this investment?

Revenues would be used to address the ongoing budget shortfall. It would help to maintain our **current** service levels and programming for the years to come in all City departments, programs, and services.

If resources generate funds beyond the ongoing budget shortfall, the community could see the results in greener parks, better library services, and prompt responses from safety services. We also want to make sure we're fixing the holes in your roads, and that your sewer and storm water systems are in good working order. All of these services combine to create a livable, safe and prosperous community that is welcoming to all.

Here's Our Recommendation...

We are continually looking for efficiencies and have been laser focused on making decisions that are "sustainable" – Ones that are economically, financially, environmentally, and publicly acceptable.

We want a lasting solution that addresses the problem, even if it feels a little unpopular right now.

McMinnville City Council,

Recent budgets show escalating expenditures while revenues remain relatively constant. An independent contractor was hired who specializes in raising revenue through taxpayers votes; the contractor's recommendation was the people of McMinnville would not likely pass an increase in tax revenue.

To my surprise, the City of McMinnville administration has responded by looking for any way around a vote of taxpayers to force an increase of revenue. Countless hours in budget committee efforts now present resolutions 2022-19, 2022-20, 2022-21 and 2022-22 for your vote.

As elected members of the City Council, taxpayers rely on your time and attention as a check to balance the power City administrators wield. We expect you to correctly weigh taxpayers' opinion by demanding the city operate within the capacity of revenue.

It is concerning that the current budget anticipates passing of these revenue generating resolutions. A minimum requirement of any council member should be to receive a balanced budget based on current revenues before passing these resolutions. - Serve to check the balance of power City administrators wield.
- Defend City of McMinnville residents from unnecessary fee increases.
