SUBJECT: Public Hearing for Fiscal Year 2019 – 2020 Budget for the McMinnville Urban

Renewal Agency

**MANDATE: ORS 294.456** 

#### **Discussion:**

ORS 294.456 allows the governing body to make certain changes to the budget that was approved by the budget committee. If the total increase in expenditures in a fund exceeds 10 percent, the governing body must publish notice of a second budget hearing and a new financial summary, and hold the second hearing before the adjusted budget can be adopted.

For the Urban Renewal Fund and Urban Renewal Debt Service Fund, the 2019-20 budget presented to the Urban Renewal Agency (URA) Board for adoption includes increases in expenditures that exceed the 10% limitation.

The proposed changes are related to capital projects that will be carried forward from 2018-19 to 2019-20. The budget approved by the Budget Committee included estimates for these projects based on what was known at the time. Increases in the 2019-20 budget presented to the Board for adoption reflect revised estimates based on current information.

**Urban Renewal Fund and Urban Renewal Debt Service Fund:** Public comment is to be taken during the budget hearing on proposed increases for 2019-20 in the Urban Renewal Fund and Urban Renewal Debt Service Fund budgets. In the Urban Renewal Fund, Public Offstreet Parking and District Identity Improvement projects were not completed in 2018-19 as anticipated. The 2019-20 budget presented for adoption reflects a total increase in appropriations of \$208,000, with increases in materials and services appropriations of \$160,000 and capital outlay appropriations of \$48,000. This allows the 2018-19 appropriations to be carried forward to 2019-20. Corresponding to the increase of expenditures in the Urban Renewal Fund, an increase of \$145,000 in Transfers Out to the General Fund appropriation is proposed in the Urban Renewal Debt Service Fund budget for 2019-20.

**MANDATE: ORS 294.456** 

#### **Discussion:**

Oregon Revised Statute (ORS) 294.456 requires the governing body of the local government to enact a resolution adopting the budget, making appropriations, and declaring the tax increment.

ORS 294.456 allows the governing body to make certain changes to the budget that was approved by the budget committee. If the total increase in expenditures in a fund exceeds 10 percent, the governing body must publish notice of a second budget hearing and a new financial summary, and hold the second hearing before the adjusted budget can be adopted.

For the Urban Renewal Fund and Urban Renewal Debt Service Fund, the 2019-20 budget presented to the Urban Renewal Agency (URA) Board for adoption includes increases in expenditures that exceed the 10% limitation.

**Urban Renewal Fund and Urban Renewal Debt Service Fund:** Public comment is to be taken during the budget hearing on proposed increases for 2019-20 in the Urban Renewal Fund and Urban Renewal Debt Service Fund budgets. In the Urban Renewal Fund, Public Offstreet Parking and District Identity Improvement projects were not completed in 2018-19 as anticipated. The 2019-20 budget presented for adoption increases materials and services appropriations by \$160,000 and capital outlay appropriations by \$48,000, allowing the 2018-19 appropriations to be carried forward to 2019-20. Corresponding to the increase of expenditures in the Urban Renewal Fund, an increase of \$145,000 in Transfers Out to the General Fund appropriation is proposed in the Urban Renewal Debt Service Fund budget for 2019-20.

Resolution 2019-02 adopts the 2019-2020 budget for the fiscal year beginning July 1, 2019, makes appropriations, imposes property taxes, and declares the tax increment.

NOW, THEREFORE, BE IT RESOLVED BY THE MCMINNVILLE URBAN RENEWAL BOARD OF THE MCMINNVILLE URBAN RENEWAL AGENCY, as follows:

- 1. Adopting the Budget: The Board of the McMinnville Urban Renewal Agency hereby adopts the budget for 2019 2020, now on file at City Hall, 230 NE Second Street, McMinnville, Oregon, as approved by the Urban Renewal Budget Committee and amended by the Urban Renewal Agency Board, in the sum of \$ 1,189,854.
- **2. Making Appropriations:** The amounts for the fiscal year beginning July 1, 2019 are for the purposes shown below and are hereby appropriated as follows:

Declaring Tax Increment:** The McMinnville Urban Renewal Agency Board hereby resolves to certify to the county assessor a request for the McMinnville Urban Renewal Plan Area for the maximum amount of revenue that may be raised by dividing the taxes under Section 1c, Article IX, of the Oregon Constitution and ORS Chapter 457.

This resolution shall take effect immediately upon passage and shall continue in full force and effect until revoked or replaced.

Mr. Kircher has been attending MURAC meetings for the past eight months and has been a valuable resource with a lot of institutional knowledge about the downtown planning process. He is an engaged business and property owner in the district.

Finance Director Baragary explained that on May 15, 2019, the Urban Renewal Agency Budget Committee approved the 2019-2020 Urban Renewal Budget. ORS 294.453 requires that after the local government's budget committee has approved the budget, the governing body must hold a budget hearing to take citizen testimony on the approved budget.

Five to 30 days before the scheduled hearing, ORS 294.448 requires that the governing body publish a "Notice of Budget Hearing and Financial Summary." The Notice includes the date, time, and location of the budget

hearing and a summary of the 2019 - 2020 Approved Budget. The Notice must appear in a newspaper of general circulation. The required Notice and Financial Summary were published in the News Register on May 28, 2019 and have been posted on the City website.

Council President Menke called for public comments from the audience.

No public comments were made.

Council President Menke closed the Public Hearing at 9:59 p.m.
