Discussion:

On May 18, 2020, the City's Budget Committee approved the Urban Renewal District 2020–2021 Budget. ORS 294.453 requires that, after the local government's budget committee has approved the budget, the governing body must hold a budget hearing to take citizen testimony on the approved budget.

Five to 30 days before the scheduled hearing, ORS 294.448 requires that the governing body publish a "Notice of Budget Hearing and Financial Summary." The Notice includes the date, time, location and remote access instructions for the budget hearing and a summary of the 2020 – 2021 Approved Budget. The Notice must appear in a newspaper of general circulation.

The required Notice and Financial Summary were published in the News Register on May 29, 2020.

The City also has a Budget Public Comment page on its website to facilitate the community's ability to weigh in on budget matters in a remote way during the public health emergency.

Recommendation: Hold budget hearing as required by ORS 294.453
