Report in Brief:

On April 11, 2023, the Budget Committee had a work session regarding the City's American Rescue Plan Act (ARPA) project status. Staff received guidance that budget adjustments for the approved package of 28 projects are supported, though for one project (the Library's HVAC system proposed additional investment), additional research is needed before considering a budget adjustment in that single case.

Discussion:

McMinnville received \$7,718,600 of State and Local Fiscal Recovery Funds (SLFRF), the component of the \$1.9 trillion American Rescue Plan Act (ARPA) package targeted to support the efforts of local governments to respond to and recover from the negative impacts of the coronavirus pandemic. In November 2021, after a series of discussions with the Budget Committee, Council approved 28 projects for spending with a maximum total budget of \$6,698,000, leaving just over \$1 million in future allocations to be approved.

The approved projects are divided into three categories:

Innovative High-Impact

- Immediate-Impact Community
- Internal Efficiency and Effectiveness

Approximately 80% of approved project dollars will be invested in community-facing projects with 20% going to more internal city organizational effectiveness and efficiency activities.

Of the 28 currently approved projects, three are proposed to have budget reductions:

The proposed action would increase ARPA project budget allocations a net total of \$201,621 for an overall allocation of \$6,899,471 authorized. \$817,467 remains available for utilization on allowable activities to respond to and recover from the negative consequences of the Covid-19 pandemic.

Staff is confident that there is little risk that the City would be forced to return any unspent funds remaining as we are running up to the project's initial closing date of December 31, 2024, so waiting to make final decisions about the allocation of the entire grant award is a perfectly reasonable approach to take. Flexibility is built into the ARPA grant generally. McMinnville is eligible to use over \$6 million of its total

allocation for revenue recovery. McMinnville's status as a recipient of less than \$10 million total funding means lower financial and programmatic reporting hurdles.

City staff are working to refine information relevant to the Library's HVAC replacement project and bring back budget information for consideration in the next four to six weeks.

Feedback from the Budget Committee meeting on April 11, 2023, indicated interest in retaining the balance of funds in unallocated status until the City is further along in spending on the authorized projects as future cost overruns could occur for those projects which are slated to begin later on in the ARPA project window.

This action is in function of the allocation of the multi-year ARPA funds for specific projects and does not affect the annual McMinnville budget appropriations for FY2022-23.

Fiscal Impact:

The use of ARPA funding is budget neutral relative the City's general and other funds. This decision will allocate more of the City's one-time funding from now through December 2024 (obligated) and December 2026 (expensed).

Council Options:

- 1. Pass the resolution making budget adjustments on twelve ARPA projects (staff recommendation). This will allow staff to make adjustments to their ARPA projects that will result in improved outcomes and the maximization of contracting period through December 2026. These adjustments also address cost overruns due to supply chain issues and inflationary pressures that were unknown when project estimates were made in the summer of 2021 and recognize the availability of new funding for broadband activities.
- 2. Reject the resolution and maintain the current projects at their current budget levels. This will mean reducing the desired impact of several projects by forcing a reduced scope to stay within the current budget levels. Actual expenditures already incurred, most notably the FY2021-22 actual impact of Covid-19 related absences in the workforce valued at over \$100,000, will need to be covered by general fund instead of the ARPA grant.
- 3. Update specific project budget adjustments. Additional discussion or budget review can be undertaken on any or all of the projects listed in the resolution. This would delay the ability of staff to move forward with planning and has opportunity cost implications as it would require additional Council, Budget Committee and staff time. On the upside, it might add value to the planning process of some individual projects to review them in more depth.

RESOLUTION NO. 2023 -19

A Resolution of the Common Council of the City of McMinnville approving allocation of American Rescue Plan Act (ARPA) funds.

RECITAL:

Whereas, the United States federal government adopted the American Rescue Plan Act of 2021 (ARPA): and

Whereas, a component of ARPA allocates Coronavirus State and Local Fiscal Recovery Funds (SLFRF) to state and local governments which granted the City of McMinnville (City) a total of approximately \$7.7 million in SLFRF; and

Whereas, the City's Budget Committee conducted work sessions to determine how the City may use the SLFRF and these discussions resulted in the Budget Committee recommending and the City approving use of funding, in Resolution No. 2021-54, for twenty-eight (28) phase one projects; and

Whereas, the forecast for spending needs have changed due to unforeseen financial and external factors; and

Whereas, due to supply chain issues, availability of parts, cost increases, and, for some projects, allowable contract terms through December 2026 that maximize use of the SLFRF; and

Whereas, these allocation adjustments are for the multi-year ARPA grant period that stretches from FY2020-21 through FY2026-27 and do not change budget appropriations for the current FY2022-23 municipal budget; and

Whereas, availability of alternate federal funding and new directives from the State of Oregon, City organizational needs, and scope changes that meet the original intent of the approved ARPA projects in phase one.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF MCMINNVILLE, OREGON, as follows:

1. Adopt the following increases to spending authority for phase one projects: The Common Council of the City of McMinnville adopts the following changes to spending authority for phase one ARPA projects.

The approvals for additional ARPA SLFRF allocations to projects have no fiscal impact on the General Fund, Information Services Fund or Wastewater Services Fund.
