Agency Budget Committee.

BACKGROUND:

ORS 294.414(1) requires a local government to establish a budget committee for purposes of acting as the local government's fiscal planning advisory committee. The committee is comprised of the elected members of the governing body and an equal number of electors of the local government (i.e., qualified voters). The governing body appoints electors to the budget committee for three year terms.

Resolution No. 2014-2, adopted by the McMinnville Urban Renewal Agency (URA) Board on March 11, 2014, established the URA Budget Committee and provided that the City of McMinnville Budget Committee shall also be appointed as members of the McMinnville URA Budget Committee.

There are currently two vacancies on the City and Urban Renewal Agency (URA) Budget Committees. The vacancies were advertised in the News Register on October 9, 2018 and November 13, 2018, as well as on the City website. We received six applications for the vacant positions.

Applications were received from Cherry Haas, Leanna Gautney, Pete Christensen, Roger Lizut, Michael Schick, Jerry Hart. Because Mr. Hart has several years of experience serving on the Committee, it was determined that he would not need to be interviewed. The other applicants were interviewed by members of the Audit Committee (Mayor Hill and Council President Menke) on December 7th, 2018.

Mayor Hill and Council President Menke recommend the reappointment of Jerry Hart for a 3-year term and the new appointment of Cherry Haas to a 3-year term.

Recommendation:

Staff recommends that the URA Board appoint the candidates to the Budget Committee, as recommended by the Audit Committee.
