Prescription Pick-up & Delivery Program

Following the lead of several other municipalities in Oregon, the City of McMinnville and Yamhill County Emergency Management will begin offering a Prescription Pick-Up & Delivery Program for our county's most vulnerable population to promote social distancing. McMinnville's Code Compliance & Community Relations officers will offer this service for individuals known to be especially vulnerable to the effects of COVID-19 for the duration of the governor's executive order, currently set to expire on April 28, 2020.

**To participate, a resident of Yamhill County must be aged 60 or older and have a life threatening, preexisting medical condition.**

Deliveries will only be made to private residences in Yamhill County between the hours of 9 a.m. & 4 p.m. Monday - Friday. For safety considerations, we cannot deliver to assisted living communities, care facilities, senior centers, or group homes.

To participate, a resident must do the following:

- Contact our Code Compliance team at 503-434-7305 during normal business hours (8 a.m. - 4 p.m. Monday-Friday) to request service
- Provide their name, address, phone number and date of birth
- Provide the name of the pharmacy and the medication being requested
- Contact their pharmacy and order the prescription
- Pre-pay for the prescription over the phone
- Advise the pharmacy that McMinnville Code Compliance will be picking up the prescription
- Have valid identification available when the officer arrives at your residence. The officer will

confirm delivery of the prescription by taking a photo of the identification in lieu of a signature to minimize person-to-person contact.

Staff will always be in approved City of McMinnville or Yamhill County Emergency Management attire with identification, will utilize personal protective equipment, and will maintain social distancing for all deliveries.

For the City of McMinnville and Yamhill County to effectively administer this program, we are asking that only those who are known to be vulnerable to the effects of COVID-19, by being over 60 years of age and having a life threatening pre-existing medical condition, utilize this service.
