

McMinnville Business Recovery and Resiliency Plan

The McMinnville Business Recovery and Resiliency Plan ("Plan") is a State American Recovery Plan Act ("ARPA") \$750,000 project secured by Rep. Ron Noble (HD-24) in the 2021 Oregon Legislative Session. The Plan addresses the ongoing issues related to the impacts of the COVID-19 pandemic. In addition, it supports the community's MacTown 2032 strategic plan goal of Economic Prosperity and is intended to have enduring value. This Plan has four (4) programs to deliver resources that address the ongoing impacts of the COVID-19 pandemic. This Business Assistance Grant is one of the programs. Business Assistance Grant for Workforce Recruitment and Retention

The Business Assistance Grant for Workforce Recruitment and Retention has been developed to address the ongoing workforce issues related to the impacts of the COVID-19 pandemic. The Grant will provide funds to businesses within the McMinnville city limits to invest in recruitment and retention programs that encourage employees back into the workforce and develop loyalty for employees to stay. The total grant fund is \$115,000.

ELIGIBILITY

To be eligible, the applicants must:

- Have a business within the city limits of the City of McMinnville.
- Be experiencing ongoing workforce issues related to COVID-19.
- Have 30 or less full-time employees.
- Have been in business for at least one year.
- If required by Oregon law, be registered with the Oregon Secretary of State to business in Oregon.

The following businesses are <u>ineligible</u> to apply for or receive funding under this Grant:

- Passive real estate holding companies and other entities holding passive investments.
- Businesses that experience workforce issues for reasons other than those caused by the COVID-19 epidemic (e.g., seasonal, or cyclical businesses cycles).
- Businesses that are delinquent on federal, state, or local taxes that were due on or before the date of application.
- Businesses that do not comply with all federal, state, and local laws and regulations.
- Businesses that do not otherwise meet the eligibility requirements set forth above.

Grant Review Process

- After the close of the grant round, the applications will be reviewed by a committee of city staff, stakeholders, and members of the City of McMinnville's Economic Vitality Council Committee.
- 2) The review committee will score the applications.
- 3) The top scoring applicants <u>may be</u> invited to meet the review committee to answer questions about their applications.
- 4) The committee will make recommendations for awards.
- 5) Awards will be announced on July 28, 2023.
