As part of the MAC-TOWN 2032 engagement and inclusion priorities of creating a culture of acceptance and mutual respect that acknowledges differences and strives for equity, a subset of the McMinnville Diversity, Equity, and Inclusion Advisory Committee (DEIAC), led by the two of us as the DEI Resources Sub-Committee, held one-hour introductory sessions with three DEI experts: Vivi Caleffi Prichard, Marci Jenkins, and Dion C. Jordan.

We recommend moving forward with Dion C. Jordan for the next step of holding education sessions with the DEIAC. Information about Mr. Jordan and his work can be found at <u>https://www.sawubona.us.com/</u>.

Pending approval from DEIAC at our 2/10/22 meeting, we will proceed to work with Mr. Jordan to develop a session or sessions for DEIAC members, hopefully to begin soon after our new members begin their terms in March. We will propose a budget when we have a specific plan to present for DEIAC's approval.

After those sessions, we will discuss as a whole committee next steps: namely, determining appropriate next steps for training for City Councilors.
