<u>2005 – 2006 Special Capital Project Fund</u> <u>Budget Highlights</u>

♣ Housing Rehabilitation Community Development Block Grant (CDBG) --- During fiscal 2005 – 2006, the housing rehabilitation CDBG will be completed.

↑ Yamhill County Affordable Housing Corporation:

- The Yamhill County Affordable Housing Corporation (YCAHC), a local non-profit corporation, was formed to conserve and rehabilitate housing located in Yamhill County.
- As YCAHC is a non-profit corporation, YCAHC cannot directly receive Housing and Urban Development federal grants.
 CDBG grants must be applied for in the name of a city or county.
- Consequently, the housing rehabilitation CDBG funds must be recorded in the City of McMinnville's budget.
- Also, federal grant dollars are subject to special federal single audit procedures and must be disclosed in the City's financial statements for federal single audit purposes.
- The Housing Authority of Yamhill County administers this grant for the Yamhill County Affordable Housing Corporation and the City of McMinnville.



✓ Virginia Garcia Memorial Health Center Primary Clinic Community Development Block Grant (CDBG) --- During fiscal 2005 – 2006, construction of the new Virginia Garcia Memorial Health Center Primary Care Clinic is expected to begin. The total project is estimated at \$2,375,000.

♦ Virginia Garcia Clinic (VGC):

- During fiscal 2003 2004, Virginia Garcia Clinic approached the City to apply for a CDBG grant. As VGC is a non-profit corporation, VGC cannot directly receive Housing and Urban Development federal grants. CDBG grants must be applied for in the name of a city or county.
- Since the grant application for the awarded \$600,000 CDBG includes \$1,250,700 project match. Even though these project match dollars are from other sources than the City, these dollars must also flow through the City's budget.
- Federal grant dollars are subject to special federal single audit procedures and must be disclosed in the City's financial statements for federal single audit purposes.
- The City of McMinnville contracts with Mid-Willamette Council of Governments for grant administration.
- No City of McMinnville money is dedicated to this project, although Administrative and Finance staff time is devoted to this project.

Special Capital Projects Fund is totally funded by grants and donations.



1989

City awarded Housing and Urban Development (HUD) community development block grant (CDBG) to purchase a residence for Henderson House Family Crisis Shelter -\$102,500.

1990

City awarded HUD CDBG for the historic Samuel Cozine House Restoration Project -\$90,000, future home of the McMinnville Downtown Association.

1991

City awarded first HUD CDBG for city housing rehabilitation projects - \$210,000. City contracts with Housing Authority of Yamhill County to administer the grant and rehabilitation projects.



Housing Rehabilitation Revolving Loan Fund used to help low income homeowners make emergency or deferred maintenance housing rehabilitation improvements.

Housing Rehabilitation Revolving Loan Fund, administered by the Housing Authority of Yamhill County (HAYC).

Special Capital Projects Fund --- Historical Highlights

1993

City awarded HUD CDBG to help build a stand-alone McMinnville Senior Center -\$600,000.

1995

City awarded HUD CDBG for Juliette's House Renovation Project - \$341,500 – Child Abuse Prevention Center. City contracts with Mid-Willamette Council of Governments (MWVCOG) to administer the liaison with Juliette's House for the project.

1997

City awarded second HUD CDBG for city housing rehabilitation projects - \$330,000. City contracts with Housing Authority of Yamhill County to administer the grant and rehabilitation projects. 2002

Housing Authority of Yamhill County incorporates Yamhill County Housing Rehabilitation Association and 1991 and 1997 HUD CDBG assets and loans receivable transferred to this new nonprofit corporation.

2003

City awarded third HUD CDBG for city housing rehabilitation projects - \$300,000. City contracts with Housing Authority of Yamhill County to administer the grant and rehabilitation projects. Grant assets and loans receivable property of Yamhill County Housing Rehabilitation Association.

2003

Yamhill County Housing Rehabilitation Association changes name to Yamhill County Affordable Housing Corporation.



Special Capital Projects Fund --- Historical Highlights

2004

City awarded HUD CDBG for Virginia Garcia Clinic (VGC) to help VGC build the Virginia Garcia Memorial Health Center Primary Care Clinic across Three Mile Lane from Willamette Valley Medical Center - \$600,000. City contracts with Mid-Willamette Council of Governments (MWVCOG) to administer the liaison with VGC for the City.
