Call to Order: President Garvin called the meeting to order at 6:03 p.m.

Secretary Pratt made a motion and Treasurer Traff seconded to approve meeting minutes from 1/11/2024. Motion passed unanimously 3-0

#### **Financial Report:**

Bank transactions – Should have profit & loss by next meeting. Will be typically shared on last meeting of the month.

GEMT – confirmation that we will get approx. 400,000 it has not been received yet.

City Payment – District should be getting a check from the City for ambulance revenue of approx. \$77,000.00.

Public Comment: President Garvin called for statements from citizens.

#### **Business: Action**

- a) Consultant Scope of Work and Bid George Dunkel is our rep for this. Still waiting for call back. Will be working with him soon. 3 bids were requested. One denied, and other did not respond. We will move forward with SDAO/George.
- b) OFDDA membership will cost approx. 1200.00. This organization is predominantly Fire Service. Treasurer Traff made a motion and Secretary Pratt seconded to approve moving forward with a membership with OFDDA. Motion passed unanimously 3-0.

#### Other Business:

- a) Board Committee/liaison Reports
  - LOSAP Balance report President Garvin asked what the percentage is at. The interest rate starts at 3.05%.
  - II. Branding patch has been accepted. Website is built out, no information yet on launch but logo has been added. Getting a bid now for patch from 511. 6-8 weeks for production.

  - III. Fire Chief Report:

Civil Service update: 16 applicants. Should have a draft by the next meeting.

Administration Director and Finance Manager Job Postings – finishing up the application, and supplemental sheet. Will run for 30 days but

will do first review at 2 weeks. If we have enough candidates that meet the minimum qualifications available, we will run the process early.

Once the Admin Director is on board there will be a full salary survey done for all employees.

Hiring update: Dual role and single role. We will be testing 2 candidates for the single role open position. One is from local area, one from antarctica.

IGA update: We completed this and have received all our vehicle titles. We have paid the service fee, and the charge for 99 years of use for the training grounds.

AFG grant: Opening date will be 29<sup>th</sup> of January to 8<sup>th</sup> of March. Does not list Airpack's specifically however, instead radios are top priority. Our radio system is end of life – 6yrs. Met with Sherif Elliot today and their office is in same situation. Looking at options. It is the Chiefs recommendation that we pursue the AFG grant for this. Will need 600,000 worth of radio upgrades in the next few years. This year alone, we will need 150,000. The District Board supports further investigation into options with proposed cost presented to the Board at the next meeting, or 2 meetings from now (prior to Grant).
