4. Discussion Items:

A. Construction Excise Tax Program -

- Associate Housing Planner Hietpas presented the Staff report on the Affordable Housing Construction Excisise Tax (AHCET) program, reviewing background information on implementation of the program, recommendations made by the AHC subcommittee on how to use CET funding and its allowed uses, the budget summary, the Committee's August 2024 discussion of CETs, and Staff's proposed process for awarding CET funds. During the presentation he and Community Development Director Richards answered clarifying questions from Committee members.
- Committee members discussed Staff's recommendations for distributing CET funds, review criteria that should be used to award funding, Code language that would incentivize developers to build affordable housing, and priorities and desired outcomes of CET funded programs.
- Staff confirmed they would draft the details of each program for the Committee to review at a future meeting.

- C. <u>Habitat for Humanity</u> Committee Member Curry reported on plans for new homes and townhouses in the Aspire Community Development Project, their upcoming annual fundraiser, and their small repair project program.
- D. <u>Yamhill County Action Partnership</u> Committee Member Hansen-Moore reported on utility assistance, rental assistance, and their navigation centers.
