#### A. Housing Production Strategy

Associate Housing Planner Hietpas presented the Staff report on the final Housing Production Strategy (HPS), noting the adoption timeline necessary to qualify for grant funding.

Beth Goodman, Consultant, ECONorthwest, provided background information about the 16 actions included in the HPS, answered clarifying questions from Committee members about the HPS, and presented the recommended actions via PowerPoint, detailing the purpose, impacts, funding requirements and implementation timeline for each action.

During the presentation, Committee members discussed with Staff and asked questions about rezoning land to R-5, implementation timelines, requiring a mix of housing types on annexed land, the need for accessible design, the multiple-unit tax exemption (MUPTE) program, uses of publicly owned land, demolition fees, and manufactured housing.

Discussion ensued regarding construction excise taxes (CETs), how the actions in the HPS will be assessed by the State, and actions that are unique and specific to McMinnville. Staff requested feedback from Committee members by April 7, 2025.
