#### 1. Call to Order

### A. Construction Excise Tax Program

Associate Housing Planner Hietpas said the City was working towards making CET funds available to eligible proposals for the first time. The Committee would provide a recommendation to the City Council on the best way to award available CET funding. He discussed the availability of funding to be a semi-annual notice and the application process would have up to two rounds of review per year. He gave a background on how the CET was generated and what it was to be used for. He then walked through the draft funding request application, application submittal process, and selection criteria.

Feedback from the Committee was that they had done a good job matching the criteria to the application and it made sense how it was being evaluated and what was being asked for. There was clarification that deeply affordable housing was defined as projects with 50% of the units at 50% or less of area median income and projects with 20 units or more would be prioritized. There was discussion regarding the federal tax credit, how bonus points could be awarded at the Committee's discretion, hyperlinks for the code and Comprehensive Plan criteria should be added into the application for easy reference, how the CET funding would be allocated, budget dedications and how the Housing Planner position would be 100% funded by CET, the selection review process timeline, eligibility, that a group could apply for both developer incentive and affordable housing program, and limiting a request for administrative costs to 10% or less.

This item would be brought back to the Committee as an action item in June.
