

WHAT'S NEXT...

After receiving this document, you may have the opportunity to meet **Deanna Jago**. She is your ADSS. She will be monitoring your case and assisting you through your Diversion / DUIL process.

BE AWARE YOU CAN NOT COME TO YOUR APPOINTMENT WITHOUT THESE TWO ITEMS.

1. **Complete an ADSS screening** (Must be completed in the County where your diversion was ordered). Items to bring to your screening appointment:
 - a. **\$150.00 fee:** To be paid at the time of screening. You are asked to call 24 hours prior to your appointment if you are unable to meet said appointment. If you fail to appear for your appointment, you will be charged a \$40.00 fee.
 - b. **A copy of your Police report:** This report is a narrative of your DUIL incident by the arresting officer. If you had a retained or court-appointed attorney, you may be able to obtain the report from them. If so, please have them email or fax the report to ADSS. Otherwise, you must request the report from the police department of the city where you obtained your DUIL. This may take 5-7 business days.
2. **VICTIMS IMPACT PANEL:** Fee is \$45.00. If you obtained your DUIL in Yamhill County and you attend Victim Impact panel in Yamhill County, you will not need to present to your ADSS your receipt of attendance. If you choose to attend a Victim Impact Panel in **another county**, you must present your receipt to the ADSS in Yamhill County. This can be done by email, fax, mail or in person.
3. **TREATMENT:** You will be referred to a treatment program at the ADSS screening. You must enter and complete the appropriate level of treatment, determined by your treatment provider. Fees for the treatment program are separate and you will be required to pay to the treatment program. The total cost of treatment may vary. Most insurance covers this service. After completing your treatment program, you may not be successfully discharged until all fees are paid.

Victim Impact Panel Date: **WITHIN 90 DAYS WITH ADSS**

Please understand all parties want you to succeed in completing your Diversion/DUIL program. It is important you follow through and ask questions if you are unsure or don't understand. It is important for ADSS that you are successful in meeting your obligations. You may call or email any questions and/or concerns you may have regarding this process.

If you live in another county, you will be able to attend treatment in that county. Although, you must have your ADSS screening in the county you received your DUIL.

PRICING AND FEES

ADSS SCREENING - \$150.00

CANCELATION FEE: \$40.00 if you do not show or call and miss your appointment. You must contact ADSS 24 hours prior to your appointment to cancel.

RE-REFERRAL FEE: \$25.00 will be charged to have all documents sent to new referent.

ADSS SCREENING REVIEW: \$100.00 if DUIL Diversion is revoked, and a new evaluation/screening has been ordered by the court. Screening may require an additional fee.

DUIL VICTIMS IMPACT PANEL: \$45.00
