

RESOLUTION NO. 2019-37

A Resolution approving a collection rate adjustment not to exceed 5% for Recology Inc.

RECITALS:

On October 8, 2018, Recology (the City's exclusive franchisee for the collection of solid waste) submitted a formal request to the City for consideration of an out-of-calendar rate adjustment of 10.47%, to be effective January 1, 2019, which included a 5.7% adjustment related to the increased costs of handling recycling materials. Recology's request was presented to the Council during its work session on November 13, 2018.

After reviewing the request, the Council found that a portion of the Recology proposal was reasonable and in the public interest to be effective January 1, 2019, and that the remainder of the request would be considered following an appropriate rate review study.

The rate review study has been completed and found that the proposed rates from Recology are appropriate and in compliance with the terms of the Franchise Agreement. On April 1, 2019, Recology requested that the remaining rate adjustment of 5% be granted, effective July 1, 2019.

The Council finds that Recology's request is reasonable, consistent with the terms of the Franchise Agreement, and in the public interest.

NOW THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF McMinnville, OREGON as follows:

1. Recology, Inc., is permitted to make an adjustment of its collections rates, not to exceed 5%, effective July 1, 2019, as shown in the attached Exhibit A.
2. This Resolution will take effect immediately upon passage, and shall continue in full force and effect until revoked or replaced.
