Notice is hereby given that on the 2nd day of December 2025, at the Yamhill County Clerk's Office located at 414 NE Evans St, McMinnville, Oregon preparation and the breaking of the seals will begin at 8:30 a.m. to conduct an automatic full hand recount of ballots for City of McMinnville Measure 36-237, for the November 4, 2025 Special Election.

As of today, there is a 13-vote margin between the "Yes" and "No", with "No" currently in the lead. This narrow margin triggers a mandatory automatic full recount in accordance with ORS 258.290.

ORS 258.290 If the official canvass of votes of an election reveals that the difference in the number of votes cast for or against any measure is not more than one-fifth of one percent of the total votes cast for and against the measure, the Secretary of State, in the case of a measure for which the Secretary of State is the filing officer, and the county clerk who conducted the election in the case of any other measure shall order a full recount of all votes cast for the measure.

In accordance with ORS 258.200 two counting boards have been appointed and the estimated duration of the automatic full recount is expected to take up to 8 hours (may extend beyond one day if necessary).

Observers from the media and the public may observe the recount per ORS 258.211 (2). For the recount of a measure each official measure organization may designate one authorized observer per counting board. All observers must have written authorization signed and submitted by the designated official of the affected measure organization being recounted by 8:00 a.m. Tuesday, December 2, 2025. Official observers have the right to witness the proceedings only for the purpose of ascertaining that the statutes and rules pertaining to the recount process are properly carried out.
