

Park Reservation Rules & Waiver

Vehicles within Park Areas

1. No person may operate any vehicle off roads or outside parking areas constructed or designated for motor vehicle use unless otherwise directed by authorized City staff.

Pets and Other animals

1. Pets must be leashed (no greater than 6 ft. in length) and under owner control at all times.
2. Owner must remove pet waste immediately.
3. Pets are not allowed within playground or play structure areas.
4. Pet owners may NOT tie their pet and leave unattended.

Vandalism and Litter

1. No person shall pick, cut, mutilate, remove or uproot any flora and fauna within the McMinnville Park System.
2. Park users must remove all refuse and ensure cleanliness of facility at conclusion of event.
3. No person shall write upon, burn, or otherwise deface, vandalize or cause damage to any park property.
4. No Piñatas or water balloons.

Fires/BBQ's

1. Park users may have fires only within designated fireplaces/BBQ grills.
2. Users may bring personal BBQ grills for use in the established park picnic areas; however, users must remove BBQ coals from the park at the end of event.

General

1. No person shall use alcohol or possess an open container of alcohol in any City park.
2. Park users must control any amplified sound system to not disturb other park users or the surrounding neighborhood.

3. No fireworks or explosives.
4. No person within a park shall commit an act of disorderly conduct, defined as follows: A person commits disorderly conduct when, with the intent to cause public alarm, nuisance, jeopardy or violence, or knowingly or recklessly creating a risk thereof, such person commits any of the following prohibited acts: (a) engages in fighting or threatening, or in violent behavior; (b) uses language, an utterance, or gesture, or engages in a display or act which is an immediate breach of the peace; (c) makes noise that is unreasonable or unnecessary, considering the nature and purpose of the actor's conduct, location, time of day or night, and other factors that would govern the conduct of a reasonably prudent person under the circumstances; and (d) creates or maintains a hazardous or physically offensive condition.
5. No person within a park area shall violate animal control, skateboard or smoking prohibitions within any park or park area specifically designated as limiting or prohibiting such activity or abet the use of any area in violation of posted notices.
6. Except as authorized by the Director, no person shall display, sell, offer for sale, peddle, hawk or vend any goods, merchandise, or operate any concession (fixed or mobile) within any park area.
7. Bounce Houses are permitted with a park reservation.
 - No cords can be laid across any walkways, no walkways can be blocked.
 - All equipment must be on grass.
 - Generators are allowed as long as they meet noise requirements.
 - Bouncy houses must be hand carried into the park, they cannot be driven. No cars are allowed outside of the established parking areas.
 - No in-ground stakes; sandbag usage only.
 - Renter is responsible for Bounce House at all times.
