# MCMINNVILLE'S ECONOMIC STATUS – POST COVID

---

McMinnville is the largest employment center in Yamhill County (15,000 jobs prior to the COVID-19 pandemic).

Over 1600 businesses in McMinnville city limits prior to the COVID-19 pandemic.

## Post COVID-19:

- Unemployment = 13.2%
- Largest cohort of unemployment claims are in the age groups of 25-44 years old.
- Largest amount of unemployment claims (by an overwhelming amount) is in the accommodation, food service and retail sectors.

# MCMINNVILLE'S ECONOMIC STATUS – POST COVID

---

## MDA SURVEY, APRIL 15, 2020 (45 Respondents)

**84% of businesses were forced to close due to COVID**

**93% lost significant revenue due to COVID**

**78% were worried most about their employee's financial welfare**

**64% were worried about accessing financial assistance**



# RESOLUTION NO. 2020-50 – WHAT IT DOES

---

- 1) **Authorizes the City Manager to sign a contract with Biz Oregon for the receipt of a \$100,000 forgivable loan for an Emergency Business Assistance program.**
- 2) **Approves a FY 2020/21 Supplemental Budget for the Special Assessment Fund authorizing the receipt and expenditure of funds for the Emergency Business Assistance grant program.**

# EMERGENCY BUSINESS ASSISTANCE GRANT

---

**TOTAL FUNDS: \$200,000**

**\$100,000 – Biz Oregon Forgivable Loan to City**

**\$100,000 – City Match for Forgivable Loan**

- **Ensure that historically disadvantaged individuals that own businesses have access to these funds.**
- **Ensure that these funds are supporting the small businesses unable to access or apply for federal funds.**
- **Ensure that these funds are reaching every corner of Oregon**
- **Ensure that these funds are keeping businesses operational.**

# QUALIFYING CRITERIA

---

## Qualifying Businesses:

- **For-profit and non-profit (501(C)3) corporations who were prohibited from operation based on Executive Order 20-12.**
- **For-profit and non-profit businesses that can demonstrate a one-month decline in revenue greater than 50% in the month of March, April, May, June, July or August 2020 as compared against revenue in the month of January 2020 or February 2020., or for those businesses with cyclical or seasonal revenues, the comparable month in 2019.**
- **Businesses with 25 or fewer employees.**

# INELIGIBLE BUSINESSES

---

1. **Passive real estate holding companies and others holding passive investments.**
2. **Non-profit entities that do not have federal 501(c)(3) status.**
3. **Businesses that fail to certify they are not delinquent on federal, state or local taxes that were due before the date of the application.**
4. **Businesses that do not certify they are in compliance and will comply with all federal, state, and local laws and regulations.**
5. **Businesses that are not headquartered and with principal operations in Oregon.**
6. **Businesses not registered to do business in Oregon (Secretary of State Business Registry) if such registration is required.**
7. **Performing arts venues and cultural or arts organizations that received funds under the statewide Business and Cultural Support program.**

# FUNDS DISTRIBUTION – STATE CRITERIA

# OF EMPLOYEES	GENERAL AMOUNT	60 DAY FIXED EXPENSES
0-5	\$2,500	\$5,000
6-10	\$5,000	\$10,000
11-15	\$7,500	\$15,000
16-20	\$10,000	\$20,000
21-25	\$12,500	\$25,000

Grant award amount will be reduced by any amount applicant has received from federal CARES Act funds or other federal funds including: PPP, EIDL.

---

## FUNDS CAN BE USED FOR:

- ❖ **Necessary expenditures incurred due to COVID-19**
- ❖ **Expenditures that were not accounted for in budget prior to March 27, 2020**
- ❖ **Were or are incurred during the period beginning on March 1 – December 30, 2020.**


