Dear Mr. Mayor and Members of the Council:

I would like to enter the enclosed comments in the official record for the public hearing scheduled for May 24<sup>th</sup> on the UGB expansion. I was hoping to get them done in time to go out with the Council packet and still hope that they will arrive in time for you to give them consideration along with the rest of the material for the hearing.

These comments refer strictly to the park land issue, and I would like to reiterate what I have said previously: I support the goals of the Parks and Recreation Master Plan, but I do not believe implementation of that Plan requires the use of 314 acres of expensive buildable land. While we do not agree on where the parks will eventually be located, I think we both agree that McMinnville needs to move ahead aggressively to fund the City's park needs.

I'd also like to repeat something that I said last year at the LCDC hearing: This process has gone on too long to get any value out of further public hearings. We need some sort of serious negotiation process to settle the differences and move on to implementation of the plan. Maybe negotiations won't work, but I think it would be worth the effort to try.

Thank you for the time you have spent considering these comments. I have a work commitment on the 24<sup>th</sup> and will be unable to attend the hearing.

# Comments on Issue #12 - Reduce Buildable Land Need for Parks By Mark Davis

#### Component 1 - Siting Parks on Nonbuildable Land

The Department of Land Conservation and Development (DLCD) has recommended that the City reduce the planned need for buildable land for community parks to account for the past record that indicates 52% of these parks were within the 100-year floodplain. City staff continues to recommend that absolutely none of this park land should be located where the historical record would place it and holds that 314 acres of buildable land are needed for parks development over the 20-year planning period. Another 55.02 acres of floodplain ground (Table 23, page B-26, MGMUP Appendices) is required as well as many more acres for the four types of parks the staff memo stresses are not included in the UGB Plan. In essence, the Plan is calling for over 400 acres of parks to be purchased and developed in the 2003-2023 planning period, or a "Discovery Meadows" (the latest community park) every year for 20 years.

Much of the plan to expand the UGB is based upon the historical record and unless strong evidence is offered to the contrary, the plan is generally based on that record, though often adjusted one way or another by compelling evidence. About 30 % of the land to be brought into the UGB is for parks (Table 12, Page B-15, MGMUP Appendices) and no other category of land totally ignores the historical record like this 314 acres of park land.

The staff memo declares that based on "its extensive history of maintaining parkland in the floodplain, that it is fiscally unsound, environmentally irresponsible, and not in the best interests of its citizens" for community parks to include floodplain land. In reverse order, I would argue that "best interests" is rhetorical, not evidence on which to base a decision; that "environmentally irresponsible" is possibly true but if we start applying environmental responsibility to this process the 1538-acre UGB expansion will shrink to zero; and that "fiscally unsound" is offered as an opinion without any supporting evidence in the record. With bare buildable land approaching \$150,000 an acre and floodplain ground a fraction of that (or free as has been the case with past donation offers) it appears at a minimum some sort of present value analysis should be offered before saying floodplain ground is too expensive to maintain. Such analysis should include flood insurance, something very common in the private sector to spread the risk of flood damage over a period of time. Recall that I have never said all parks should be located in the floodplain; rather that some likely will incorporate portions of the floodplain, though obviously the potentially flooded portions should not include structures like restrooms.

The other major argument the staff memo makes is that the floodplain ground is "impractical given the location of future growth." This is rather curious given that hundreds of acres of floodplains are included in the proposed UGB expansion, presumably adjacent to where future growth will occur (see maps on pages C-60, C-76, C-152, C-163, C-174 and C-197, MGMUP Appendices). I agree that ideally community parks should be more centrally located, but this principle should apply even more to high schools and the same argument carried no weight at the May  $10^{\rm th}$  hearing. The City should not confuse the theoretical ideal with practical reality.

While DLCD appears to be focusing on a simple historical floodplain analysis, I have always argued that parks can be built on other types of land deemed "nonbuildable" by the City. In fact, this is exactly what the City proposes in the staff memo when it identifies the location of one future park in the west hills where some of the land has been designated "topographically constrained," meaning putting a park here would not require using all buildable land. And remember, the City is proposing to having 264.33 acres of community parks (Table 23) by 2020, which means that in addition to the park in the west hills several other community parks will be built, presumably on the land being brought into the City.

This also brings to mind another interesting point regarding Table 22 (page B-25, MGMUP Appendices). This table does not include topographically constrained lands (i.e., steep slopes), so it is not an accurate reflection of the historical use of buildable lands for Greenways and Greenspaces. A stroll through the Tice Property (about a third of the total acreage) will show you that some of the land is clearly too steep to meet the City's "buildable" category. If the City is abandoning the "floodplain standard" for its parks needs as proposed in the staff memo, then the Greenways and Greenspaces number should be adjusted. Given that the City proposes to add 107 acres of buildable land for Greenways and Greenspaces, this is not an immaterial consideration.

Finally, it is worthwhile to step back from all the minutiae of the arguments being made regarding this issue and take a look at the big picture. The 20-year planning period for the Parks Master Plan is about one-third complete, so let's compare what was proposed with what has happened. The UGB park land need is based on the Master Plan recommended standard of 14 acres of parks per 1000 residents. The Plan was drafted in 1998 and adopted in 1999 and it was acknowledged that the standard was not being met, but that the City would move towards meeting it. In Exhibit I have graphed the City's acres of park per 1000 residents since 1998. Despite a 20-year \$9.5 million parks levy passed in 2000, the City is moving away from the standard instead of towards it. Given the other needs of the City (ironically, the proposed and desirable construction of police facilities will eliminate 2.7 acres of land currently in the parks inventory as the Wildflower Area in Table 22) it seems unrealistic that the City will purchase and develop over 300 acres of parks in the next 18 years. The Master Plan estimate 7 years ago exceeded \$52 million for 180 acres (see attached News-Register story from July 20, 1999) and was based on land costing \$50,000 an acre. The City's experience in implementing the Park Master Plan over the past 6 years offers scant evidence that it will purchase and develop even the 176.61 buildable acres that my previous testimony has suggested is justified by the historical record.


I believe this historical record more accurately reflects what is likely to happen. The alternative offered in the staff memo is certainly theoretically possible, but I do not believe a record has been established to show it is very likely. And while the staff alternative is based on the Parks Plan "standard," my previous testimony has included information from the Parks Plan to show that Plan does not preclude the use of floodplain grounds for some of the community park land need.

#### Component 2 - Sharing Park Facilities

The staff memo's response to DLCD's suggestion of reducing the need for park land by sharing facilities with the McMinnville School District and Linfield is rather mystifying. They reach the conclusion that such joint use would not work, but such joint use is taking place right now. The City has an intergovernmental agreement with the McMinnville School District to share facilities and a similar arrangement with Linfield. Attached are three pages from the current Parks and Recreation Brochure that include references to programs taking place on Linfield facilities. In conversation Parks Director Jay Pearson indicated that with 100 youth soccer teams in the community, school facilities are regularly used for team practices.

Not only is this commonsense approach currently being utilized, but it is also overwhelmingly popular with the residents (and taxpayers) of the City. The Parks Master Plan on page 26 indicates that 90 % of surveyed residents support "partnerships with McMinnville Public Schools and Linfield College for joint use of facilities." Perhaps joint ownership or operation of parks is not practical, but the type of sharing that currently takes place clearly reduces the need for the City to add as many playing fields for organized recreation and related practices.

McMinnville residents are also using school grounds for informal recreation during non-school hours. Even if you ignore such use that reduces the numbers in parks, it is clear that the formal recreation program joint use reduces the need for the City constructing further sports playing fields, which are one of the major components of community parks. Table 3 of the Parks Plan contains recommended standards for various recreation facilities such as baseball, softball and soccer fields that would be included in community parks. Since Linfield and McMinnville Schools also construct such facilities (see Table A-3 in the Parks Plan), the City should inventory the effect of the current sharing and project also the potential usage of the additional 96 acres (or 106 acres if you count the high school change) to be added for schools.

The plan has been in the works for more than two years. It is based in part on a community survey in which citizens' opinions about local parks were gathered.

"It's a working, living report that gives us a foundation," said Parks and Recreation Director Jay Pearson. "We think this reflects the community's interests."

The 63-page report, drafted by the city and the consulting firm Don Ganer & Associates, calls for continued renovation of existing parks and acquisition and development of nearly 180 acres of new parks over the next two decades. The primary funding source would be general obligation bonds and fees charged on new development.

Pearson said the plan is likely to be reviewed every couple of years as growth patterns become clearer and users' interests change.

"It shouldn't be interpreted as absolute," Pearson said. "You shouldn't pick this off the shelf and say, 'Hey, this means you're going to spend \$13 million in my neighborhood by the year 2002."


