Dear Oak Ridge Neighbors,

I think that most of you are aware that Premier Development has applied to develop the 25 acres Northwest of the Mormon Church. But I don't think most of you are aware that in their amended application that they are proposing that "**THE ONLY**" access street for the approximately 1,000 vehicles per day that development will generate is Pinot Noir drive. And they say that is for up to five years if/until Shadden street is extended on the north side of Baker Creek road to the Oak Ridge Development. If Shadden is never finished, the only access will be Pinot Noir.

By the rules, Premier has only to concern themselves with the amount of traffic that Oak Ridge was designed to carry (according to the city, 1200 car trips per day). No concern is weighed about the ability to get onto Baker Creek Road as it is now, let alone with 1,000 extra vehicles per day.

Our Friends of Baker Creek group argued against this access issue, and also their attempt to fill and develop the wetlands at an April Planning Commission hearing. But you should know that

McMinnville's Planning Department is fully behind Premier's proposal based on two Premier traffic studies that claim that neither our Oak Ridge or the Compton Crest neighborhoods have any problems merging on to Baker Creek road. So according to the regulations in place, an additional 1,000 vehicles per day won't be a hardship.

Unfortunately for us, McMinnville's Planning Department is strongly in favor of the proposal and attempting to convince the independent Planning Commissioners to approve it at their meeting next Thursday, May 16th at the Kent Taylor Civic Center (6:30). Our committee will again be asking the Commissioners to make Shadden the Primary access street to Oak Ridge Meadows – both in the development stage, and after houses have been completed. But the opposition is implying that we are just a small group of *whiners*. It sure would help our cause if we could demonstrate to the Planning Commissioners just how many Oak Ridge residents think it would be unfair to add an additional 1,000 vehicles per day on to Oak Ridge and Merlot Streets – when we already struggle to safely merge onto Baker Creek road during morning and afternoon rush hours. We are arguing that would be unfair to our neighborhood – and future Oak Ridge Meadows residents too.

We know how busy everyone is. And that most can't physically make the meeting. But we are hoping that there is still time for you to voice your opinion via an email. If you can do this, please remember this is a formal, quasi-judicial affair – so no swearing, threatening, etc. And we can't coach responses. We are simply asking you to voice your honest opinion of what you think the result will be if the Commissioners approve Pinot Noir as THE ONLY access street for the future Oak Ridge Meadows residents to use for up to five years. And maybe list what you personally think will be the largest hardships to you personally.

Our contact person at the Planning Department is Jamie Fleckenstein. I think if your email goes to him by Monday or Tuesday, it should be entered into testimony for the Commissioners to review. Please make it clear that you are writing about The Oak Ridge Meadows application. Address it to:
